Hi Cristen and John,

For Geotechnical Final, please submit:

- Geotechnical Consultant Approval Form, Section II, signed and stamped by the Project Geotechnical Consultant
- Geotechnical Final Construction Observation Letter, signed and stamped.
- Completed drill log, and piers plan
- Final Grading Report signed and stamped by the Geotechnical Project Consultant, per Grading Permit requirements
- As-built plans for final grading

The Final Construction Observation Letter usually contains the following information:

- confirmation of the foundation work product compliance to geotechnical recommendations provided in the geotechnical report
- confirmation of the grading and finish surface
- confirmation of stabilized slope and grade
- confirmation of the sub-drains and drainage system, if included in the scope of the geotechnical report
- any other scope of work that was included in the observation lists in the geotechnical report.

The Final Grading Report for the grading must verify all the following:

- The grading construction was done according to the approved plans, including the location and extent of grading, and the finish slopes of cuts and fills.
- Area where fill is placed has been properly prepared per the Approved Geotechnical Report.
- Compaction was performed and achieved per the Approved Geotechnical Report.
- Where a building pad is created, the pad is "suitable for its intended use" (i.e., to support a residential structure).
- All foundation subdrainage and drainage work have been done appropriately, where included in the Approved Geotechnical Report

Hi Christen –

Here's the final inspections for 88 Cowpens as they currently are reflected in our permit tracking system. Looks like Amanda at Sewer signed off on 7/20, but there are still quite a few others. For drainage, I need

1. Confirmation of drainage inspection corrections from 6/7 (attached email) and completion of site – Should be done with a final site walk-through that can be scheduled with me directly
2. Letter from Engineer of Record stating it was built per plan (with the change out of lined bioretention in lieu of planter)
3. Civil Engineer to provide As-Built plan for site.
4. O&M Agreement needs to be recorded for the site (Provided by Civil Engineer, OK'd by County, and then signed by responsible party) – reminder that it can take us a few days to review these, please send me a final draft sent to me sooner rather than later – the last one I have is from March (attached), but it needs the later updates that we made to lots 9 and 10 made to this one as well reflecting the conversion of the site features to bioretention rather than planters.
