	outstanding gaps for intake and entry into our system for people experience intimate partner violence. County Attorney Caiti Busch recommends a group of no more than 8 members of the Domestic Violence Council (to be mindful of the Brown Act and not reach quorum); however their meetings can involve members of the public, invited guests and other members of the DVC (as long as quorum is NOT reached; quorum is 13 members). Recommendation to include dv survivors in task force meetings. Suggested offices include: Board of Supervisors (Supervisor Corzo), County Executive Office (Adam Ely), Sheriff's Office (Christina Corpus), District Attorney's Office (Elisa Kuhl), Superior Court, SMC Medical Center, SMC Office of Education, Karen Ferguson (CORA), and Nicole Reyes (Bay Area Legal Aid) Motion by Adam Ely to create a task force to investigate the gaps & improvements with domestic violence services in San Mateo County; and this adhoc group will include the 8 mentioned representatives. Seconded by Sheriff Christina Corpus. Approved.
