Dear Ms. Leung, Mr. Monowitz and Mr. Pine:

My name is Dan Freeman. My wife and I are residents of San Mateo Timberland Park at 114 Lakewood Circle, San Mateo 94402. We are very concerned with the construction project on the side of the hill across Polhemus Road along Ticonderoga Drive in Highland Park.

I am writing to raise serious issues regarding San Mateo County's notification letter dated May 3 titled "Consideration of a proposed Minor Modification to an approved Resource Management (RM) Permit (PLN2006-00357) for the development of Lots 5, 6, 7, and 8 (BLD2016-00161 through BLD2016-00164) in the San Mateo Highlands Area". This construction project will have a serious adverse effect on the hillside open space along Ticonderoga Drive as it represents an increased risk of a landslide in the area. Also concerning are the significant changes to the originally proposed earth grading activity.

I request that the County prepare a supplemental environmental impact report and hold a public community hearing about the construction project. Thank you,
